## Today's Celebrity Speaker

Allan Siebert from Little Rock, Arkansas, is our featured speaker today.

You probably know Allan for his bridge skill and accomplishments at the table (Grand Life Master, two-time winner of the Open Swiss Teams, and #20 on the all-time ACBL Masterpoint Winners' list with more than 29,200 masterpoints) rather than his strong support for advancing the growth and development of duplicate bridge. What you probably don't know is that Little Rock has its very own bridge center, thanks in large part to a gift of over \$96,000 from Allan—the fulfillment of his commitment to match 4-for-1 the gifts of those who attended a fundraising party held in his home. Allan said at the dedication, "Way beyond winning at bridge what really matters in our bridge experience is the pleasure and satisfaction we derive from the mere challenge and the camaraderie that the game offers us."

Allan received a life-time appointment to the ACBL Charity Committee this year for his outstanding contributions on behalf of bridge.

Allan and his brother David are the second highest Masterpoint holders as brothers in the ACBL. Allan won North American Swiss in 1988 and 2003, Life Master Pairs in 1995, Senior Swiss and Senior KO Teams in 2001, and Silver Ribbon Pairs in 2007. He also has five second place finishes in national events and over 100 Regional titles. Allan is a frequent presenter at the Little Rock Duplicate Bridge Club and local tournaments.

## One Notrump Forcing

**1NT Forcing: 1♥ – 1NT or 1♠ – 1NT**

When the partnership plays 2/1 Game Force, it must also play 1NT forcing in response to an opening major suit bid. This bid applies to all hands that are not game-forcing hands after partner opens the bidding with a **major suit**. After a major suit opening, 1NT shows 6–12 total points with any distribution and is forcing for one round.

**1NT is non-forcing to a minor-suit opening bid OR when responder is a passed hand.**

### Opener's Rebid after 1NT Forcing

Unless responder is a passed hand, opener must find a rebid after opening 1♥ or 1♠ and hearing a Forcing 1NT response from partner. Most of the time, you can make your standard rebid, as if the 1NT response were non-forcing. The only exception is when you have a minimum hand with which you would pass a standard 1NT response. Since you must rebid something, you may have to manufacture a bid on a 2 or 3-card minor suit when you have 5–3–3–2 or 4–5–2–2 distributions.

#### Opener's Rebid with the Auction 1♠ – 1NT:

- 2♣: May be a 3-card suit; if so, the distribution is 5–3–2–3
- 2♦: May be a 3-card suit; if so, the distribution is 5–3–3–2
- 2♥: Natural, at least 5 diamonds and 4 hearts, non-forcing (13–18 total points)
- 2♠: 6<sup>+</sup>-card suit, minimum hand (13–16 total points)
- 2NT: Natural, invitational, 18–19 total points, balanced
- 3♣, ♦, ♥: Strong jump shift, game forcing
- 3♠: 6<sup>+</sup>-card suit, medium hand (17–18 total points)
- 3NT: Natural, 20–21 points, semi-balanced
- 4♠: Natural, usually 19–21 points, but could be a playing hand

#### Opener's Rebid with the Auction 1♥ – 1NT:

- 2♣: May be a 2-card suit; if so, the distribution is 4–5–2–2
- 2♠: May be a 3-card suit; if so, the distribution is 3–5–2–3
- 2♦: May be a 3-card suit; if so, the distribution is 3–5–3–2

- 2♥: 6<sup>+</sup>-card suit, minimum hand (13–16 total points)
- 2♠: 5 hearts and 4 diamonds, forcing for one round (Reverse), 17–18 total points
- 2NT: Natural, invitational, 18–19 points, balanced
- 3♣, ♦, ♠: Strong jump shift, game forcing
- 3♥: 6<sup>+</sup>-card suit, medium hand (17–18 total points)
- 3NT: Natural, 20–21 points, semi-balanced
- 4♥: Natural, usually 19–21 points, but could be a playing hand

### **Responder's Rebid after a Forcing 1NT Response**

The forcing 1NT response covers a wide range of hands. Responder has to be prepared to describe the hand after hearing opener's rebid.

- 1♥ – 1NT – 2♣ – Pass: The 1NT forcing response is only a one-round force. Opener must bid again but responder does not have to bid again unless opener makes a forcing bid—a reverse or a jump shift. Since the 1NT response covers a wide range, responder should plan on making an invitational rebid with any hand of 11–12 points.
- 1♠ – 1NT – 2♣ – 2♠: When playing forcing 1NT, responder has an extra incentive for returning to the major suit when holding only 3-card support for the minor suit. Opener may have been forced to bid a 3-card minor suit and the partnership does not want to play in a 3–3 fit. This is referred to as giving false preference.

- 1♠ – 1NT – 2♦ – 2NT: A rebid of 2NT, showing 11–12 points, inviting opener to bid game with a little more than a bare minimum. Responder is showing a hand that was not quite strong enough for a 2/1 response with some length and strength in the unbid suits.
- 1♠ – 1NT – 2♣ – 3♠: A jump rebid in opener's major suit; responder is showing 3-card support with 11–12 points.
- 1♠ – 1NT – 2♣ – 2♥: By responding 1NT forcing, then rebidding a new suit, responder shows a 5<sup>+</sup>-card suit with a hand too weak to respond 2♥ over 1♠. It also implies that responder does not care much for either spades or clubs. Opener will usually pass and leave responder to play part score in the named suit.
- 1♠ – 1NT – 2♣ – 3♥: A jump rebid of a new suit shows a good 6-card or longer suit and a hand of invitational value (11–12 points).

### Interference By Opponents: Forcing 1NT?

Although the 1NT response to 1♥ or 1♠ is forcing if the opponents are silent, the situation changes if the opponents interfere.

- With a takeout double or an overcall over the opening bid, the 1NT response is natural, non-forcing.
- If an opponent interferes after a forcing 1NT response, opener does not have to bid unless it is convenient to do so.
